## WELCOME TO OUR 100 CLUB!

Welcome to the Ringwood Town FC 100 CLUB – a great way for you to support us whilst having a bit of a flutter! Here's how it works...

You complete the membership form and set up a Standing Order mandate for £5 a month – then send the completed form by email to Angie. Forms are downloadable from our website: <https://www.pitchero.com/clubs/ringwoodtown>

This buys you one membership number (we will allocate 1-100), which enters you into the monthly draw. All participants must be over 16. You can be a hero and have more than 1 x number @ £5 each!

The draw will take place on 1st day of each month.

If you win, an online credit will be sent to your nominated bank account and the name of the winner published on our social media – we may need photos taken.

The total prize fund will be 50% of the membership fee taken that month. The remaining 50% goes to the club to help fund equipment, resources and opportunities for members.

The maximum prize fund is therefore  $100 \times £5 = £500 \div 2$  so £250! This will be split as 60% to the first drawn 30% to the 2nd and 10% to the 3rd – the sooner we sell all 100 numbers the bigger the prize becomes!

## **RULES**

## **PURPOSE**

**The purpose of the 100 Club is to raise funds. The money will be paid into the club's bank account and used to meet various funding requests for the club.**

## **RULES**

1. For a cost of £5 per month (i.e. per draw) you will be allocated one number between 1 and 100. You can 'own' more than one number!
2. A draw will be made every month with a 1st, 2nd and 3rd prize.
3. The prizes will total 50% of the total income per month.
4. This will be apportioned as: 1st prize of 60%, 2nd prize of 30% and 3rd prize of 10% of the prize fund.
5. The 100 Club is a society lottery and is open to all club members aged 16 or over.
6. Numbers are unlimited – the aim is to get 100x numbers sold ASAP.
7. Payments must be made by standing order monthly. One month's notice is required for cancellation.
8. Member's numbers will only be entered if their subscription is up to date.
9. If a member has no valid reason for missing a payment, their number may be sold to someone on the reserve list.
10. The draw shall be made by the Chairman or their nominated representative on the 1st of each month.
11. The winning prizes will be paid by BACS into the account on your application within 14 days of the draw.
12. The name and numbers for each month's winners will be in our club's social media – this may require a photo.
13. The 100 Club will be run by Angie Collins. In case of any dispute the decision of the Committee is final.
14. Unless otherwise advised, a member will be deemed to have left the 100 Club if his/her subscription renewal remains unpaid for a period of one month.
15. If a winner cannot be contacted, the winnings will be placed into Club funds after six months.
